9. STATEMENT OF FAITH

- 1. We believe the Holy Bible was written by men divinely inspired and is all sufficient rules/verbal and plenary of faith and practice. 2 Timothy 3:16, 2 Peter 1:21, Ps 12:6-7, 1 Thessalonians 2:13, 2 Peter 3:15-16
 - a. We believe the King James Bible to be the inspired, inerrant and preserved Word of God for the English-speaking people today.
- 2. There is one and only one living and true God. In the Unity of the God Head, there are three personalities, The Father, The Son and The Holy Spirit, each executing distinct, but harmonious offices in the great work of redemption.
- 3. All individuals by nature are sinners. Romans 3:23
- 4. A Church is a local congregation of Scripturally Baptised believers covenanted together for the purpose of carrying out the commission given by Christ.
- 5. Salvation of sinners is completely of grace (not works) through the Mediatorial Offices of the Son of God.
- 6. All persons will be eternally saved at the time they repent of their sins and trust Christ to save them personally. These believers will live in Heaven eternally with Christ.
